Subject:- Grant of Grant-in-Aid to Mahila Mahavidyalaya, Jhojhu Kalna (Bhiwani)

Reference to the subject cited above.

In this connection it is informed that the Govt. have decided to give 95% Grant-in-Aid to your college on the salary of the approved staff from the year 2008-09 (i.e. 01.01.2009) on the following conditions:-

1. The qualification of the staff (teaching/non teaching) should be in accordance with the norms fixed by the U.G.C. and the Haryana Government from time to time.
2. The pay scales to the teaching and non teaching staff should be as per the norms fixed by the UGC and the Haryana Government issued from time to time.
3. The college shall not create/divert any post without the prior approval of the Finance Department.
4. The Grant-in-Aid for the financial year 2008-09 shall be met by the department from the sanctioned budget of Private Colleges.

The grant-in-aid would be admissible in respect of the following posts as sanctioned by the Government:-

I. Teaching

5. Lecturer Ph. Sc.	=	1
6. Lecturer Math	=	1

9. Lecturer Geography	=	1
10. Lecturer Commerce	=	2
11. Lecturer Environment Studies	=	1 ——— 1 vacant

II. Non-Teaching

1. Clerk	=	1 ——— 1 vacant
2. Peon	=	3 ——— 2 vacant
3. Sweeper	=	1 ——— 1 vacant

The vacant posts be filled up through duly constituted Selection Committee only, if there is justification on the basis of work load and student strength in the next academic session i.e. 2009-10.
